सातारा, दि. २५ (वार्ताहर) : सातारा जिल्हा वार्षिक सर्वसाधारण योजनेसाठी सन २०२२-२३ या वर्षाकरिता ४०० कोटी रुपयांचा निधी मंजूर करण्याची घोषणा उपमुख्यमंत्री तथा वित्त नियोजन मंत्री अजित पवार यांनी आज केली. दूरदृश्यप्रणालीद्वारे आज झालेल्या राज्यस्तरीय प्रारूप आराखडा अंतिम करण्याच्या बैठकीत उपमुख्यमंत्री श्री. पवार यांनी राज्यात प्रत्येक जिल्हा मुख्यालयाच्या ठिकाणी महिला व बाल भवन आणि दिव्यांग भवन उभारणार असल्याचे सांगितले. या बैठकीस मंत्रालयातून सहकार पणन तथा पालकमंत्री बाळासाहेब पाटील दूरदृश्य प्रणालीद्वारे आमदार पृथ्वीराज चव्हाण, मंत्रालयातून राज्याचे मुख्य सचिव देबाशीष चक्रवर्ती, वित्त विभागाचे प्रधान सचिव तथा सातारचे

मुंबई, दि. २५ (प्रतिनिधी) : मुलींच्या लग्नाचे वय अठरा वर्षावरून २१ वर्ष करण्यात यावे यासाठी केंद्र सरकारकडून निर्णय घेण्यात येणार आहे. मात्र केंद्र सरकारने हा निर्णय घेण्याअगोदर सर्व स्तरावर या बाबतची चर्चा करण्यात यावी, अशी मागणी केंद्रीय मंत्री स्मृती इराणी यांच्याकडे आपण केली असल्याचे राष्ट्रवादीच्या खासदार सुप्रिया सुळे यांनी सांगितले. त्या महाराष्ट्र राज्य महिला आयोगाच्या २९ व्या वर्षांपन दिनानिमित्त घेण्यात आलेल्या कार्यक्रमात बोलत होत्या. तसेच महाराष्ट्रात याबाबत स्वतंत्रपणे चर्चा झाली पाहिजे असं मतही त्यांनी या कार्यक्रमादरम्यान मांडले. मुलींचे लग्नाचे वय २१ वर्ष करावे. हा केंद्र सरकारचा निर्णय माझ्या वैयक्तिक पातळीवर मला चांगला वाटत असला तरी, हा निर्णय संपूर्ण देशावर परिणाम करणार आहे. त्यामुळे या निर्णय घेण्या आधी सर्वांगीण चर्चा होणे गरजेचे असल्याचेही त्यांनी यावेळी सांगितले.
